In the previous exposures we explained that the only way liberation movements could be freed was out of the norms of dominance relations between the superpowers and the oppressed peoples of the world and we noted that the embassy was the spy den of the imperialists, the center of conspiracy and plots against the Islamic Iranian Revolution and we presented the reasons which obliged us to occupy this den of espionage. Now we will present documents to the general opinion of the world, documents which prove that this place had to be closed so that plots end conspiracy would end.

In the room behind room 225 in the main building of the embassy among the remaining material we found instruments which indicated that in this place illegal acts of forging documents and stamps took place and we found an envelope containing two stamps which are used when entering and leaving countries. The authorities of Mehrabad claim that these stamps should only be found in the airport office. A tablet containing all numbers for the dates was also found. Apparently the stamps have been used before.

But the problem is what are these stamps used for. Smugglers and spies use these forged stamps to enter the country and criminals wanted by the police use them to escape from the country. Now one must ask why these two stamps were found in the former U.S. embassy. The American government and people must respond to this question. The American government must answer why it allows diplomats and representatives to forge documents of other countries. Does the American people accept the responsibility of the escape the thousands of thieves murderers and criminals from our

OUT IRAN, DERAKHSHESH IS ONE OF RELATIVELY FEW PEOPLE IN IRAN WHO CAN MOBILIZE SOME SORT OF ORGANIZATION. HE INDICATED HE WOULD DEARLY LOVE TO FOLLOW CONCILIATORY COURSE WHICH WOULD PERMIT SHAH TO REMAIN AND REIGN, NOT RULE, BUT GOVERNMENT HAS CLOSED DOWN ALL EFFORTS HE AND HIS GROUP HAVE MADE TO PUBLISH OR BE POLITICALLY ACTIVE.

2. DERAKHSHESH DESCRIBES GROUP THAT FOLLOWS HIM AS MAJORITY OF TEACHERS. 2. I CANNOT SUGGEST THAT THERE HAS BEEN ANY SIGNIFICANT CHANGE AS YET IN THE KIND OF OFFICIAL AND PUBLIC REACTION TO THE SHAH ENTERING THE UNITED STATES THAT WOULD DIFFER FROM THE ASSESSMENT I GAVE YOU IN LATE JULY (TEHRAN 7030). THE CONSTITUTIONAL TIMETABLE HAS SLIPPED AND A NEW GOVERNMENT IS NOW UNLIKELY TO BE INSTALLED BEFORE THE END OF THIS YEAR. OUR OWN RELATIONSHIP IS IMPROVING BUT ONLY SLOWLY, AND IT IS NOT YET OF THE SUBSTANCE THAT WOULD WEATHER VERY WELL THE IMPACT OF THE SHAH ENTERING THE UNITED STATES.

3. MEANWHILE THE CLERICS HERE ARE IN THE ASCENDANCY, AND THAT I FEAR WORSENS THE PUBLIC ATMOSPHERE AS REGARDS ANY POSTURE ON OUR PART TOWARD THE SHAH. THAT WAS ILLUSTRATED THIS PAST WEEK IN THE VERY TOUGH REMARKS BY KEMENI CONCERNING THE SHAH IN HIS REPORTED INTERVIEW WITH OFIANA FALLACI, IN WHICH HE DENOUNCED THE SHAH AS A TRAITOR WHO MUST BE RETURNED TO IRAN AND TRIED PUBLICLY FOR FIFTY YEARS OF CRIMES AGAINST THE IRANIAN PEOPLE.

4. GIVEN THAT KIND OF ATMOSPHERE AND THE KIND OF PUBLIC POSTURING ABOUT THE SHAH BY THOSE WHO CONTROL OR INFLUENCE PUBLIC OPINION HERE, I DOUBT THAT THE SHAH BEING ILL WOULD HAVE MUCH AMELIORATING EFFECT ON THE RESPONSE OF REACTION HERE. IT WOULD PRESUMABLY MAKE OUR OWN POSITION MORE DEFENSIBLE IF WE WERE SEEN TO ADMIT HIM UNDER DEMONSTRABLY HUMANITARIAN CONSIDERATIONS.

5. THAT BEING SAID, IT IS AS YOU INDICATE OF UTMOST IMPORTANCE THAT WE TALK QUIETLY WITH THE GOVERNMENT OF IRAN IN ADVANCE IF WE INTEND TO ADMIT HIM, EVEN FOR A VERY SHORT PERIOD. IF WE DO INTEND TO TAKE SUCH ACTION AND IF THE MATTER IS URGENT, CLEARLY THE BEST MEANS OF SECURING SOME COOPERATION FROM THE PCOI WOULD BE FOR THE SECRETARY TO RAISE IT WITH YAZDI WHEN HE SEES HIM ON OCTOBER 3. 2. SUMMARY: AS RESULT OF TURN FOR WORSE IN U.S. - IRAN TIES, PROBLEM OF WILLINGNESS TO TALK WITH EMBOFFS NOTED REPTELS A AND B IS INCREASING. LATENT EFFECT OF CONTROVERSY OVER AMBASSADOR CUTLER'S APPOINTMENT AND CONTINUING CHARGES THAT U.S. AND CIA ARE MEDDLING IN IRAN HAVE SIGNIFICANTLY INCREASED FEAR OF BEING SEEN WITH OR TALKING TO EMBOFFS TO POINT WHERE IT IS IMPAIRING OUR EFFORTS TO ACQUIRE INFORMATION. END SUMMARY.
3. UNWANTED CONSEQUENCE OF TURN FOR WORSE IN U.S.-IPAN RELATIONS IS DRYING UP OF MANY OF OUR BEST SOURCES AND AN INCREASING UNWILLINGNESS ON PART OF IRANIANS TO BE SEEN WITH OR TALK TO U.S. EMBASSY OFFICIALS. BEGINNING WITH REACTION TO MAY 17 SENATE RESOLUTION, THEN DEMONSTRATIONS AT EMBASSY MAY 24-26, YAZDI'S COMMENTS ON CUTLER IN PRESS (REF C), AND HEAVY MEDIA ATTACKS ON U.S. (REF C AND D), SITUATION HAS DETERIORATED SIGNIFICANTLY EVEN FROM IMMEDIATE POST-REVOLUTIONARY PERIOD.
4. FOUR-YEAR VETERAN ECON OFFICER NOTES THAT MANY WHO WOULD FORMERLY RECEIVE HIM IN THEIR OFFICES OR ANSWER QUERIES BY PHONE NOW AT BEST ASK FOR PRIVATE MEETINGS OR WILL PHONE AT NIGHT (CONVINCED THAT THE EMBASSY PHONES ARE COMPROMISED) AND ARE GENERALLY RELUCTANT TO DISCUSS MATTERS THEY TALKED OF FREELY SIX OR EIGHT MONTHS AGO. MANY, DUE TO LONG, WARM ASSOCIATION ARE EMBARRASSED TO FLAT OUT REFUSE BUSINESS OR SOCIAL APPOINTMENTS, REPEATELLY GIVE THE "PERSIAN PUT-OFF" WITH PROMISES TO CALL, ETC. FARSI-SPEAKING PETROLEUM OFFICER, FINISHING THREE-YEAR TOUR, REPORTS SIMILAR DIFFICULTIES WITH MANY OF HIS EXTENSIVE CONTACTS. SOME NO LONGER HAVE ACCESS TO PREVIOUSLY-HELD INFORMATION; ALMST ALL ARE RELUCTANT TO TALK.
5. ALL POLITICAL SECTION OFFICERS HAVE EXPERIENCED SAME PHENOMENON. IN MANY CASES, SOURCES HAVE LEFT COUNTRY. EVEN PERSONAL FRIENDS OF FOUR-YEAR TOUR TEHRAN POLOFF ARE RELUCTANT TO MEET WITH HIM, THOUGH SOME REMAIN WILLING TO SEE HIM PRIVATELY AT THEIR HOMES. OF COURSE, A FEW CONTACTS SEEK POLITICAL OFFICERS OUT, BUT THESE ARE FREQUENT-

LY FEELING SOLUTIONS AND ARE NOT ALWAYS THOSE WE MIGHT PREFER TO TALK WITH. OTHERS WHO HAVE BEEN HERE MORE THAN SHORT TIME REPORT SAME RELUCTANCE, OF EVEN LONG-TIME FRIENDS, TO BE SEEN PUBLICLY WITH OFFICIAL AMERICANS.

6. CHARGE HAS NOTED THAT OF SOME DOZEN FORMER IRANIAN AMBASSADORS WHO HAVE RETURNED TO TEHRAN WHOM HE KNEW PERSONALLY IN THE PAST, NONE HAVE TRIED TO GET IN TOUCH WITH HIM SINCE THEIR RETURN TO TEHRAN. VETERAN RETIRED AMBASSADOR TOLD POLOFF THAT MANY OF HIS COLLEAGUES ARE COMING TO SEE ANY AMERICAN CONNECTION AS "PROFESSIONALLY VERY DANGEROUS THING IN ISLAMIC IRAN." WILL BE INTERESTING TO SEE HOW MANY IRANIANS ARE WILLING TO TURN UP AT FAREWELL FUNCTIONS FOR VETERAN OFFICERS WHO WILL BE DEPARTING WITHIN NEXT MONTH.

7. POST'S EXPERIENCE IN OBTAINING INFORMATION ON JEWISH PROBLEM HERE IS EXCELLENT CASE IN POINT. WHILE WE HAVE MANAGED TO GET TO SOME SOURCES WHO WILL HELP US, THEY ARE ALL SCARED AND FEARFUL OF WHAT EFFECT U.S. CONTACT WILL HAVE ON THEM (REF E AND F).

8. SOME OF OUR PRIVATE CITIZEN CONTACTS HAVE NOTED INCREASED SUSPICION OF THEM AMONG IRANIAN COLLEAGUES AND FRIENDS. THIS IS PARTICULARLY ACUTE IN UNIVERSITIES, WHERE LEFT HAS BEEN BOMBARDING INTELLECTUALS WITH ANTI-U.S. MATERIAL. AS ONE CONTACT PUT IT, "EVEN THOSE WHO OUGHT TO KNOW BETTER ARE BEING SWEEP ALONG BY THE TIDE."

9. THERE IS NO DOUBT THAT CONTEXT BEING ESTABLISHED BY CURRENT EVENTS IS MAKING IT MORE DIFFICULT FOR US TO GATHER KIND OF INFORMATION WE NEED. WHILE SITUATION HAS NOT YET REACHED LEVEL IN SOME THIRD-WORLD STATES WHERE CONTACT BETWEEN EMBASSY PERSONNEL AND LOCAL CITIZENS IS SEVERELY RESTRICTED OR CONTROLLED, BASIC IMPACT OF RECENT WEEKS HAS PUSHED IRAN IN THAT DIRECTION. 1. (U) This letter establishes guidelines to be used by USDAO personnel for handling and submitting visa referrals and amplifies procedures contained in referenced Consul General's letter.
2. (C/NOFORN) Visa referrals by USDAO personnel will be limited to immediate family members of, A. Iranian military, (gendarmarie) and police officers equal to the rank of field grade or above; B. the civil aviation organization, and C. senior Iranian or foreign diplomatic officials who have a direct association with the Defense Attache Office. Friends of the above will not be handled. Visa referrals will only repeat only be handled to gain intelligence information useful to the United States Government. Applicants who do not meet requirements of A, B or C above, but are considered to be extra-ordinary cases (i.e. Homafars who have provided valuable information to DAO) will only be approved by Colonel Schaefer. Those applicants who do meet A, B or C above will be approved by the DATT or Acting DATT before submission to the Consular Office.
3. (C/NOFORN) The visa referral service can be very valuable to the Defense Attache Office for gathering information not normally accessible through other means, but it should not be abused. Contacts are important, but only if they provide us information or open doors that will lead to valuable intelligence. I expect quid pro quo from these contacts and information that will show up in intelligence reports.
4. (U) As a guideline for the Defense Attache Office, we should submit no more than five referrals per week. Those people who do not meet the limitations in paragraph 2 above; but include personal friends that DAO

1. THE FOLLOWING TRADE COMPLAINT WAS PRESENTED TO THE EMBASSY BY MEHDI RUMGHANI. MR. RO GHANI'S FATHER SHELTERED AYATULLAH KHOMENI DURING HIS LAST 15 DAYS IN IRAN PRIOR TO HIS EXILE IN 1963. THE FAMILY, THEREFORE, HAS CLOSE PERSONAL TIES TO KHOMENI AND HIS GROUP. RUMGHANI HIMSELF WAS MOST HELPFUL TO THE EMBASSY IN OBTAINING THE RELEASE OF MARINE SGT. KRAUS WHO WAS HELD FOR SEVEN DAYS FOLLOWING THE FEBRUARY 14 ATTACK ON THE EMBASSY. PROMPT ACTION ON THE FOLLOWING COMPLAINT WOULD THEREFORE BE APPRECIATED.

2. THE RUMGHANIS HAVE FOR 27 YEARS BEEN THE FORD DEALERS FOR IRAN. IN OCTOBER OF 1977 IN THE COURSE OF A MEETING IN LONDON, AN AGREEMENT WAS REACHED ACCORDING TO WHICH FORD WOULD PAY THE RUMGHANI'S A 4 PER CENT SERVICE COMMISSION ON CARS PURCHASED OUTSIDE OF IRAN AND LATER IMPORTED. FOLLOWING THE AGREEMENT, FORD REQUESTED INFORMATION REGARDING THE VEHICLES IN COUNTRY, ALL OF WHICH WAS PURPORTEDLY FURNISHED, AND CHECKED TWICE BY FORD REPRESENTATIVES. ABOUT 1500 VEHICLES ARE INVOLVED AND PER MR. RUMGHANI, AGREEMENT WAS REACHED ON THE SUM TO BE PAID. HE NOW WISHES TO KNOW WHEN FORD CAN BE EXPECTED TO MAKE PAYMENT. THE CONTACT IN LONDON IS MR. RUDOLPH H. BONIFACE, VICE PRESIDENT WIL-EAST AND AFRICA SALES OPERATIONS, 169 KINGS ROAD, BRENTWOOD ESSEX CM 144 EN, TELEPHONE, BRENTWOOD 219 500, TELEX 995511.

3. FOR LONDON: PLEASE INFO THE DEPARTMENT WHEN YOU RESPOND. FOR THE DEPARTMENT: DEPENDING UPON THE INFORMATION DEVELOPED IN LONDON, FOLLOW-UP WITH THE FORD MAIN OFFICE MAY OR MAY NOT BE APPROPRIATE.

4. IN ADDITION TO THE SERVICE COMMISSION PROBLEM, RUMGHANI HAS A SECOND ONGOING DISAGREEMENT WITH FORD REGARDING THE SALE OF ABOUT 60 HEAVY DUTY TRUCKS TO THE NATIONAL IRANIAN OIL COMPANY (NIOC). HIS CLAIM IS THAT THE DIFFERENCE BETWEEN THE FORD EXPORT SALES PRICE AND THE SELLING PRICE TO NIOC IS DUE HIM, THE DEALER. NIOC PAID FORD DIRECTLY AND HE HAS YET TO BE REIMBURSED THE SUM HE FEELS IS DUE HIM. THIS PROBLEM APPARENTLY DATES BACK ABOUT FOUR YEARS AND HAS NOT BEEN RESOLVED. ANY INFORMATION YOU COULD DEVELOP REGARDING FORD'S POSITION AND THEIR WILLINGNESS TO MAKE PAYMENT WOULD BE APPRECIATED.

2. SUMMARY: RADICAL MOVEMENT LEADER MOGHADAM GAVE DEPTOFF PRECHT HIS VIEWS ON THE CURRENT POLITICAL SITUATION AND STRONGLY URGED THAT CHARGE PAY CALL ON KHOMEINI TO CONVINCE IRANIANS OF USG ACCEPTANCE OF REVOLUTION. END SUMMARY.

2. IN THE COURSE OF A DISCUSSION ON A VARIETY OF SUBJECTS SEPTEMBER 29, RADICAL MOVEMENT LEADER RAHMATOLLAH MOGHADAM-MARAGHEIE, A MEMBER OF THE COUNCIL OF EXPERTS REVIEWING THE CONSTITUTION, REPLIED TO A QUESTION ON HOW THE U.S. COULD IMPROVE ITS RELATIONS WITH IRAN BY STRONGLY URGING THAT THE U.S. CHARGE CALL ON KHOMEINI AS SOON AS POSSIBLE. MOGHADAM APPEARED CONCERNED THAT THE U.S. HAD NOT MADE ANY EFFORT TO REQUEST AN APPOINTMENT SINCE MAY, AND URGED THAT NO MATTER WHAT THE DIFFICULTIES MIGHT BE, THE U.S. SHOULD ASK IMMEDIATELY FOR AN APPOINTMENT. MOGHADAM POINTED OUT THAT THE TIME WILL NEVER BE RIGHT, THAT KHOMEINI IS NOW OLD AND QUITE INFLEXIBLE. HOWEVER, SHOULD KHOMEINI DIE SUDDENLY BEFORE THE U.S. PAYS A CALL, EVEN MODERATES WHO DO NOT FULLY SUPPORT KHOMEINI WILL CRITICIZE THE U.S. AND SAY THAT THE LACK OF A MEETING WAS A SIGN OF THE U.S. LACK OF ACCEPTANCE OF THE REVOLUTION. MANY WOULD BLAME THE U.S. FOR KHOMEINI'S DEATH.

4. MOGHADAM WAS HOPEFUL, BUT NOT PARTICULARLY OPTIMISTIC, ABOUT THE POLITICAL SITUATION. HE FELT THAT KHOMEINI HELD THE ALLEGIANCE OF THE MASSES AT THE MOMENT AND THAT OVER THE PAST FEW WEEKS HE HAS TAKEN AN INCREASINGLY HARD STAND ON THE ISLAMIC REPUBLIC. KHOMEINI IS ALIENATING THE INTELLECTUALS AND MOGHADAM FELT THAT AT SOME POINT SOON HE WILL REALIZE THIS AND RECTIFY THE SITUATION. MOGHADAM SAID THAT HE SUPPORTS KHOMEINI AND THE IDEA OF THE VALIAT-E-FAQIH BUT THAT HE FEELS THE FAQIH SHOULD NOT HAVE POLITICAL POWER. MOGHADAM SAID HE THOUGHT THE CONSTITUTION WOULD BE FINISHED BY THE COUNCIL OF EXPERTS IN 3-4 WEEKS. IN RESPONSE TO PRECHT'S QUESTION, HE SAID HE HAD TALKED TO BEHESHTI ABOUT POSSIBLE CHANGES IN THE DRAFT AND BEHESHTI SAID HE WOULD BE WILLING TO REVIEW ALREADY PASSED ARTICLES IF THEY WERE INCONSISTENT. MOGHADAM NOTED THAT PRIME MINISTER BAZARGAN HAD EARLIER ASKED HIM THE SAME QUESTION AS PRECHT. MOGHADAM DID NOT SEEM TO HOLD OUT MUCH HOPE THAT THE PRESENT FORM OF THE CONSTITUTION WOULD BE CHANGED. HE DID NOT REPEAT NOT FEEL THAT A REFERENDUM ON THE CONSTITUTION OR ELECTIONS COULD

BE HELD ANYTIME SOON GIVEN THE PROBLEMS IN KURDESTAN. IF THE TEXT WERE NOT CHANGED, ESPECIALLY THE SUNNI-SHIA PROVISION, THE REFERENDUM MIGHT NOT GO WELL FOR THE REGIME.

5. MOGHADAM SAID THAT MANY PEOPLE WERE CRITICIZING SHARIAT-MADARI FOR LACK OF LEADERSHIP AT THIS POINT. THIS WAS UNJUST AS THIS WAS THE WRONG TIME AND KHOMEINI WAS TOO STRONG AT PRESENT FOR SHARIAT-MADARI TO OPPOSE. THE TIME WOULD COME, MOGHADAM INTIMATED, AND THE AZERBAJANI ARE JUST WAITING FOR A SIGNAL FROM HIM.

6. QUESTIONED ON THE PROSPECTS FOR PEACE IN KURDESTAN. MOGHADAM FLATLY STATED HE SAW NO POSSIBILITY THAT THE CURRENT PEACE EFFORTS BY THE GOVERNMENT WILL SUCCEED. HAD THE GOVERNMENT MADE THIS TYPE OF EFFORT 6 WEEKS AGO IT MIGHT HAVE WORKED BUT HE SAW NO POSSIBILITY NOW. HE COULD OFFER NO SOLUTIONS FOR SETTLEMENT.

7. AT THE END OF THE CONVERSATION, MOGHADAM URGED THAT MORE VISITORS BOTH OFFICIAL AND UNOFFICIAL SUCH AS RAMSAY CLARK AND RICHARD COTTAM BE SENT TO IRAN TO STAY IN TOUCH WITH IRANIANS OF ALL POLITICAL PERSUASIONS.
